# Financial Report

- o Year-end financials done
- No significant fundraising last year due to Pandemic
- o Spent the casino money as required, going to Chrome Books and charging carts.

- Staff appreciation was the other significant expense
- o Overall spent \$35K in 2020-2021.
- \$21,600 in funds on hand this year to date
- o Budget in draft; current general expenses are targeting \$8K
- Annual Financial Statement for year is ready for audit; Kim Heit and Kerri Holmes will do the audit this year.

# **Fundraising Updates**

#### a. Hot Lunch Report

- o Kathi Engel is this year's hot lunch coordinator; Terri Ackroyd will support
- o First round of hot lunch pulled in \$18K in orders (not including expenses); this year we will be short 2 sessions of hot lunches due to starting in October instead of September.
- Approximately 20 volunteers signed up; email reminder of proof of vaccination or negative test.
- Hiccup in getting sign-up form to junior highs; Kathi resolved
- First hot lunch is October 25; Kim will continue to do the shopping for the miscellaneous hot lunch supplies
- Motion to approve up to \$500 for hot lunch coordinator supplies for the year. Seconded by April Childs. All in favor. Carried.

#### b. Loyalty Card

- o Orders need to be in this Friday, October 15. Vendor will distribute all the cards.
- o 29 have been sold to date (approx. \$450).

#### c. Little Caesars

- Discussed logistics of distribution; pandemic protocols can be managed
- o Michelle will get more details from vendor to determine if this is feasible this year

#### d. Grants

a. Drama group applied for Dow grant

#### **New Business**

- a. PAS donated \$1000 to the Fun Run Club for both Fall and Spring 2021 2022 season
- b. Leader In Me subscription cancelled due to significant cost increase this year
- c. Mr. Huculak will discuss outdoor classroom and space opportunities with Mrs. Rice
- d. Staff Appreciation
  - o \$1324 spent last year
  - o Motion to approve \$1500 for staff appreciation for the year. Seconded by Terri Ackroyd. All in favor. Carried. April Childs will take lead on this initiative.
